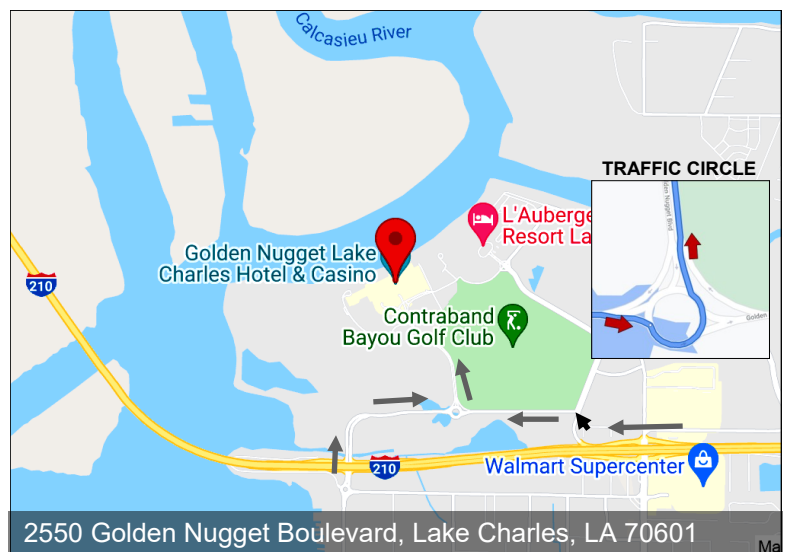


From The West:

- Take the traffic circle and proceed north. (2nd traffic circle exit)



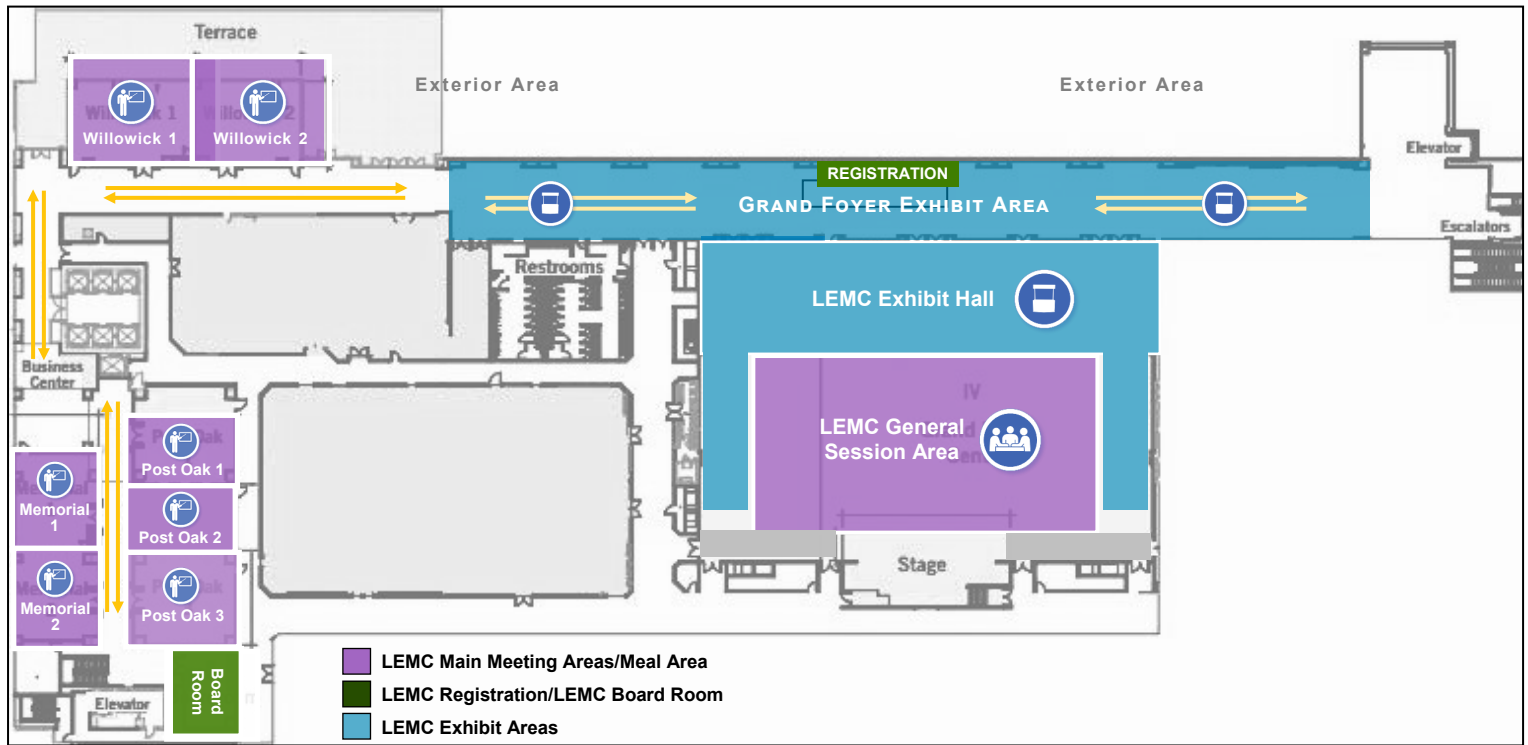
From The East and North East:

CANCELLATION/REFUND POLICY

If a registrant is unable to attend an event for any reason they may substitute, by arrangement with the registrar, someone else from the same institute/organization.

Where the registrant is unable to attend, and is not in a position to transfer his/her place to another person, then the following refund arrangements apply:

- ◆ Registrations cancelled more than 30 days before the event will be refunded 80% of the registration fees.
- ◆ Registrations cancelled less than 30 but more than 15 days before the event will be refunded 50% of the registration fees.
- ◆ Registrations cancelled less than **15 days** before the event will not be eligible for a refund.
- ◆ Registrations cancelled due to a declared state of emergency within their jurisdiction are eligible for a refund less a \$15 processing fee. Registrants will need to provide a copy of the declared state of emergency to the LEMC Committee.
- ◆ Cancellation fee is **\$75.00** non-refundable.

Emergency Illness or Death of Registrant or Immediate Family Member:

Refunds may be granted if an attendee is unable to attend the conference due to a family death, illness, or other extraordinary circumstance approved by the LEMC Committee.

In such a circumstance, the Main Office must be contacted by phone, letter or e-mail. If initial notification is by phone, it must be followed up in writing within 15 days. Refunds will still be subject to the \$15 processing fee and the membership fee will be retained for those non-member registrations.

No Show Policy:

Refunds will not be granted for no-shows (registrants who do not attend the conference with no prior notice of cancellation). Delegates assume full responsibility for notification to and verification of receipt by the LEMC Committee.

Refunds will be made in the following ways:

For payments received by credit or debit cards, the same credit/debit card will be refunded.

For all other payments, a bank check will be made to the payee.

It also supports compliance with FEMA's data requirements, ensuring accurate documentation for federal disaster assistance and funding eligibility.

LEMC FEATURED SPEAKERS

Jeff Landry Governor, Louisiana



Jeff Landry's love for our state, and his passion for helping others is defined by his Louisiana roots. Jeff grew up in the small town of St. Martinville where his mother was a schoolteacher and his parents took him to church every day. Later, Jeff learned the value of hard work in the sugar cane fields and then proudly joined the National Guard, serving in Operation Desert Storm. After returning home, Jeff worked as a police officer and sheriff's deputy, and later started a successful business and went to law school. As a public servant, both as a U.S. Congressman and the Attorney General of Louisiana, Jeff Landry has shown strength and courage fighting for common sense values and bringing people together to deliver solutions.

On October 14, 2023 Jeff Landry was elected to become the 57th Governor of Louisiana in a historic primary victory. On January 8th, 2024, he assumed office.

Jeff resides in Broussard, Louisiana with his wife, Sharon, and their son, JT.

Major General Thomas C. Friloux The Adjutant General of Louisiana



Major General Thomas C. Friloux was appointed the 51st Adjutant General of Louisiana by Governor Jeff Landry on January 8, 2024. He serves as the Commanding General of both the Louisiana Army National Guard and the Louisiana Air National Guard. He is responsible for providing the State of Louisiana and the United States of America with a ready force of more than 11,000 service members of the Louisiana National Guard prepared and equipped to fight our Nation's wars and respond to the State's emergencies.

Major General Friloux attended Officer Candidate School and was commissioned into the Infantry in 1992. His previous command and staff positions include: Commander, A Troop 108th Cavalry; Commander, A Company 3-156th Infantry; Commander, B Company 3-156th Infantry; Operations Officer, 3-156th Infantry; Executive Officer, 3-156th Infantry; Operations Officer, 256th Infantry Brigade Combat Team; Commander, 2-156th Infantry; J7 - Joint Director of Plans, Louisiana National Guard; J3 - Joint Director of Operations, Louisiana National Guard; Director of the Joint Staff, the Louisiana National Guard; and Dual-Status Commander, Joint Task Force Louisiana.

Major General Friloux has mobilized into active federal service four times during his career. In 1990, he mobilized in support of Operation Desert Storm and Desert Shield. In 2004, he mobilized and deployed to Iraq in support of Operation Iraqi Freedom II/III. In 2010, he mobilized and deployed to Iraq in support of Operation Iraqi Freedom X and Operation New Dawn. In 2021, he mobilized with US Northern Command as the Dual-Status Commander in response to Hurricane Ida in Louisiana.

He earned a Bachelor of Science in Psychology from the University of Louisiana at Lafayette in 1995, a Master of Arts in Military Studies with a concentration in Land Warfare from the American Military University in 2011, and a Master of Strategic Studies from the U.S. Army War College in 2016. His military education includes the Infantry Officer's Basic and Advanced Courses, Combined Arms Services and Staff School, Command and General Staff College, the U.S. Army War College, and the Joint and Combined Warfighting School.

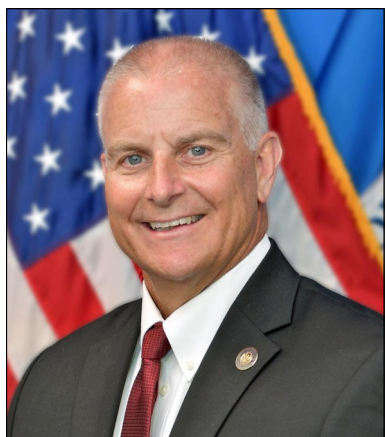

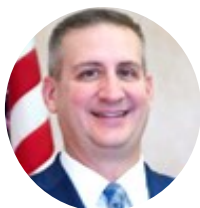

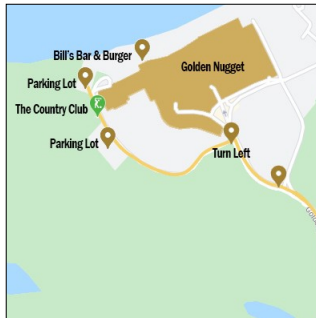
